The Chairman moved the President's report that appeared in the newsletter for acceptance, seconded by Corey Harris – and **carried unanimously**.

Treasurer's Annual Report:

The Treasurer highlighted the items that were listed in the prepared Club's audit thanks to Alan Styles.

President's Annual Report

Hello members,

Firstly, I would like to thank Richard Hawley for his support and tireless efforts as secretary throughout the year, he is the one who keeps the club running smoothly. He has now been doing the secretary's job for 14 years. (Almost due for long service leave). I would also like to thank John Quarry for his outstanding effort as treasurer, and the other members of the committee for their support.



This past year has seen an average of 28 members attending the club meetings. The \$ value of takings has increased due to sales from the fly bowl, raffles and other items that have been sold. Thanks must go to the members who donate flies, books, fly-tying material and other items to the club.

For the 2023 – 2024 season there has been a slight increase in shack usage, with September, November, December, January and February being the most popular.

The merger of CFF&FCA and the FFCT has seen the continuation of their fly casting at the Grindelwald base, and their inter club casting competition with the DFFC continue under the FFCT banner.

Thanks to Bill Greensmith and his trusty helpers the club has continued with the Basic Flyfishing classes.

This past year has been reasonably quiet for the club with no major works being done.

At Koongara new mattresses were purchased and the bunks resized thanks to the carpentry skills of Graeme Frankcombe. From all reports this has been a great success.

We also held a very successful wood cut, with 17 members attending and around 12 cubic meters of wood being cut. Thanks to Peter Berne there are now 3 more small tanks in which the wood can be stored, it is now up to the members who stay at Koongara to keep these full.

There are still some minor works planned for Koongara, i.e... The sign off of the 240-volt electrical system and the raising of the solar panels to prevent debris collecting under them.

At Noonameena new mattresses the same as Koongara will be purchased.

It is also planned to upgrade the hot water system; this will also require an upgrade of the electrical system.

always kept neat and tidy.

This year the club held several club outings the first being the Lake Fergus Foray with 7 members attending and a good number of fish caught.

Unfortunately, road access to this water has been stopped for the 2024 -2025 season, foot access is still available via the designated walking track.

This year in place of the Lake Fergus trip we have planned a trip to Pine Tier Lagoon, this is on the $22^{nd} - 24^{th}$ of November.

The second club outing was the Penstock One Fly, with 14 members attending, some fishing from boats and others from the shore, returning to the shack later in the afternoon for a well -earned BBQ. The go to fly was a possum emerger.

This Year it is planned to have members arrive between 9.00 - 9.30 am for a breakfast of egg and bacon muffins, then heading out to fish for the day and returning to the shack later in the afternoon to decide who is going to get their name on the trophy. The Penstock One Fly this year will be held on December the 14^{th} .

On Sunday the 21^{st of} January the Cane Day was held with 21 participants, some from the club and others from outside the club. Money raised from this event was donated to Mending Casts (women fly fishers with breast cancer). Thanks to Chris Crawford for organizing this event. This year it will be held on January 26th.

The Pine Plunder was held on Saturday the 27th of January. Only 2 members attended, this may have been due to the weather conditions, heavy cloud, strong W/NW wind with gusts up to 50 kph. There were no duns showing, but a possum emerger was readily taken, lots of fish were hooked and lost. The Pine Plunder in 2025 will be held on the 11th of January.

The annual Clean Up Australia Day was held on Saturday the 9th of March, with not much rubbish collected. In 2025 CUAD will be held on the 8th of March.

We have had several guest speakers, covering a range of topics throughout the past year, with guest speakers planned for the coming year.

The December meeting will be a club trivia night with raffles, drinks and nibbles, so come along and test your knowledge.


